- (1) Austria: ICE, ELI, ELM, MAG: 60.00EUR/AWB Recheck fee (EUR 100/time for DG that require Shipper's Declaration, EUR 60/time for DG that does not require Shipper's Declaration) will be required in case correction is required.
- (2) Belgium: ICE, RRE, REQ, RDS, ELM, ELI, MAG: EUR35.00/AWB Radioactive (RRY, RRW): Minimum EUR105.50/AWB.
- (3) Canada: +CAD15.00/additional pcs from the 2<sup>nd</sup> pcs
- (4) Chinese Taipei: Recheck fee (TWD 800/time) will be required in case correction is required. In the event of incomplete documentation prior to cargo acceptance, the initial correction of deficiencies will not be included in the number of times the recheck fee is charged.
- (5) France: ICE, RRE, REQ, MAG, ELI, ELM: EUR35.00/AWB

Any other 'Small DG' shipment which does not require DGD will not be charged.

Check Fee (EUR66.50/AWB) will be required in addition to RA Fee for RRW/RRY shipments.

Recheck fee (EUR 92.00/time for DG that require Shipper's Declaration, EUR 70.00/time for DG that does not require Shipper's Declaration) will be required in case correction is required.

- (11) Netherlands: Recheck fee (EUR 650/time) will be required in case correction is required.
